Pursuant to Chapter 103D, HRS, SEALED TENDERS will be received up to and opened at 12:00 p.m., Hawaiian Standard Time (HST) on <u>Friday, May 04, 2018</u>, in the Administration Office of the Department of Water at 4398 Pua Loke Street, Līhu'e, Kaua'i, Hawai'i ("DOW Admin. Office"). Bids received after the date and time specified above shall be rejected. Facsimile offers will not be accepted or considered.

The Manager and Chief Engineer also reserves the right to reject any or all bids, in whole or in part, if deemed to be in the best interest of the Department of Water.

Bids must be signed in ink by the person or persons duly authorized to sign bids in the space provided for signature on the Offer form.

BIDDERS ARE HEREBY NOTIFIED THAT EVIDENCE OF THE AUTHORITY OF THE PERSON(S) SIGNING THE BID DOCUMENT IS REQUIRED TO BE INCLUDED WITH THE BID DOCUMENTS. FAILURE TO COMPLY WITH THIS REQUIREMENT WILL BE CAUSE FOR REJECTION OF THE BID AS BEING NON-RESPONSIVE.

SCOPE OF WORK: The Contractor shall be responsible for all materials, labor, tools, permit fees, equipment, and incidentals to abandon/seal Hanamā'ulu Wells #1 & #2 in accordance with the DLNR-CWRM, Hawai'i Well Construction & Pump Installation Standards, as Revised February 2004. See Appendix G for the Well Completion Reports of Hanamā'ulu Wells #1 & #2. The Contractor shall coordinate with CWRM to obtain the appropriate permit prior to beginning construction.

The Contractor shall mobilize all necessary equipment and tools to complete this project as soon as possible after award of the bid and issuance of Notice To Proceed. The location of Hanamā'ulu Wells #1 & #2 and right of entry areas are indicated in Appendix C. The Contractor shall be responsible to follow all the Terms and Conditions of the right of entry documents.

After successful completion of each well abandonment, the Contractor shall clean the site to its pre-project condition or better as determined by the Board in its sole and absolute discretion. Contractor shall remove all equipment from the site prior to final payment.

Contractor shall submit a Well Abandonment/Sealing Report to the Board and DLNR-CWRM upon satisfactory completion of the above work. Well Abandonment/Sealing Report shall be accepted by the Board and DLNR-CWRM prior to final payment.

<u>CONTRACTORS LICENSE</u>: All prospective Bidders must be currently licensed by the State of Hawai'i, Department of Commerce and Consumer Affairs, Division of Professional and Vocational



Licensing.

"A" general engineering contractors and "B" general building contractors are reminded that due to the Hawai'i Supreme Court's January 28, 2002 decision in Okada Trucking Co., Ltd. v. Board of Water Supply, et al, 97 Haw. 450 (2002), they are prohibited from undertaking any work, solely or as part of a larger project, which would require the general contractor to act as a specialty contractor in any area where the general contractor has no license. Although the "A" and "B" contractor may still bid on and act as the "prime" contractor on an "A" or "B" project (See, HRS § 444-7 for the definitions of an "A" or "B" project), respectively, the "A" and "B" contractor may only perform work in the areas in which they have the appropriate contractor's license (An "A" or "B" contractor obtains "C" specialty contractor's licenses either on its own or automatically under HAR § 16-77-32.). The remaining work must be performed by appropriately licensed entities. It is the sole responsibility of the contractor to review the requirements of this Project and determine the appropriate licenses that are required to complete the Project.

PRE-BID CONFERENCE: All potentially interested offerors, subcontractors, and union representatives are invited to attend a non-mandatory pre-bid conference on Monday, April 9, 2018 at 9:00am. A visit to the site will be conducted following the meeting. The site inspection is not mandatory; however, submission of an offer shall be evidence that the Offeror understands the scope of the project and shall comply with the specifications herein, if awarded the contract and has thoroughly familiarize itself with the existing conditions, rules and regulations, and the extent and nature of work to be performed. No additional compensation, subsequent to bid opening, shall be allowed by reason of any misunderstanding or error regarding site conditions or work to be performed. All prospective Bidders must make their own transportation arrangements to and from the site.
