Pursuant to Chapter 103D, HRS, SEALED TENDERS will be received up to 2:00 p.m., Hawaiian Standard Time (HST) on **Friday, June 12, 2015**, at the Office of the Department of Water, Līhu‘e, Kaua‘i, Hawai‘i. Proposals received after the date and time specified above shall be rejected.

The Manager and Chief Engineer also reserves the right to reject any or all proposals, in whole or in part, if deemed to be in the best interest of the County.

Proposals must be signed in ink by the person or persons duly authorized to sign proposals in the space provided for signature on the proposal form.

PROPOSERS ARE HEREBY NOTIFIED THAT EVIDENCE OF THE AUTHORITY OF THE PERSON(S) SIGNING THE PROPOSAL DOCUMENT IS REQUIRED TO BE INCLUDED WITH THE PROPOSAL DOCUMENTS. FAILURE TO COMPLY WITH THIS REQUIREMENT WILL BE CAUSE OF REJECTION OF THE PROPOSAL AS BEING NON-RESPONSIVE.

SCOPE OF WORK: This contract consists of furnishing and installing materials for approximately 425 linear feet of 12-inch C-900 PVC pipe, 2,281 linear feet of 8-inch C-900 PVC pipe, 564 linear feet of 6-inch C-900 PVC, 302 linear feet of 2 ½-inch schedule 80 PVC, 30 linear feet of 8-inch ductile iron pipe, and appurtenances including connections to existing waterlines, relocate existing laterals and meter boxes, new valves, new fire hydrants, installation of air valves and permanent cleanouts with meter boxes, valves, and valve boxes, and all restoration and repaving works, all in accordance with the RFP documents, plans and specifications.

All prospective offerors must be currently licensed by the Hawai‘i Department of Commerce and Consumer Affairs, Division of Professional and Vocational Licensing.

“A” general engineering contractors and “B” general building contractors are reminded that due to the Hawai‘i Supreme Court’s January 28, 2002 decision in Okada Trucking Co., Ltd. v. Board of Water Supply, et al., 97 Haw. 450(2002), they are prohibited from undertaking any work, solely or as part of a larger project, which would require the general contractor to act as a specialty contractor in any area where the general contractor has no license. Although the “A” and “B” contractor may still submit a proposal on and act as the “prime” contractor on an “A” or “B” project (*See*, HRS §444-7 for the definitions of an “A” or “B” project), respectively, and the “A” and “B” contractor obtains “C” specialty contractor’s licenses either on its own, or automatically under HAR §16-77-32.). The remaining work must be performed by appropriately licensed entities. It is the sole responsibility of the contractor to review the requirements of this project and determine the appropriate licenses that are required to complete the project.
