In case of default in the payment of principal as herein provided, the Department of Water shall discontinue service to the premises. Upon default of payment of principal, the whole amount of principal shall become immediately due and payable. The Holder agrees to give the Makers notice telling the Makers that the Makers are in default. Failure to exercise this option shall not constitute a waiver of right to exercise the same in the event of any subsequent default.

If the Holder requires the Makers to pay immediately in full as described above, the Holder shall have the right to be paid back all of its costs and expenses to the extent permitted by applicable law. These expenses include but are not limited to: any court or collection costs and reasonable attorney's fees.

The Makers hereby expressly waive demand, protest and notice of demand, protest and nonpayment, and extensions of time of payment without written notice.

No provision of this Note may be waived, modified or cancelled orally, but only by an agreement in writing and signed by the party against whom enforcement of any waiver, modification, discharges or cancellation is sought.

This Note shall be governed by and construed according to the laws of the State of Hawai'i.
